FEATURED FUND

WESTERN ALASKA DISASTER RECOVERY FUND

The act of giving financial support does not define success in philanthropy. It is not a question of what you alone can do; it begins with the question, "How can we solve this together, so the funds gifted can create solutions from the perspective of those in need?"

It is in this spirit that the people of Alaska and all over the world stepped up to support Western Alaska after Typhoon Merbok. Seeing the need, ACF established the Western Alaska Disaster Recovery Fund on September 17. With the support of more than two thousand individuals, businesses, Alaska Native organizations, and corporate sponsors, the fund grew to over \$1.7 million in less than two months.

The outpouring of support surprised the residents of communities along the Western Alaska coast. The reaction wasn't just due to the substantial amount of money raised but because so many cared and trusted them to use the funding in ways they deemed best.

With the overwhelming nature of the devastation and the apparent long-term work needed for a successful recovery, the ACF team met with local leaders to best understand how this collective generosity could be leveraged for the greatest impact. It was decided that grants would be given over time and distributed as unrestricted funding, allowing grantees to assess and determine where grant dollars were most needed immediately and in the future months.

Based on the advice from regional leaders, ACF distributed over half a million



2022, less than a month after the initial disaster. Funds were directed to provide much-needed support as soon as possible to the communities that were hit hardest, including Golovin, Hooper Bay, Newtok, and Chevak. In November, additional funding was distributed as the needs were identified.

The goal was, and is, to create an authentic partnership with grantees using tenants of trust-based philanthropy, allow innovation, emergent action, and sustainability to guide decision-making. This approach is equally valuable in looking at the inevitability of future large-scale storms in the region.

As ACF continues to partner with and listen to the needs of grantees, we aim to establish a solid groundwork for the whole of Alaska. We are focused on a future that acknowledges and embraces opportunities to advance collectively toward a flourishing and sustainable Alaska where every experience and perspective is sought and considered to grow and improve philanthropy.

TOP TEN OF 2022

1,984 nonprofits received over \$35 million in grants from funds held at ACF to enhance and support communities across the state.

132 Alaskan students working to achieve their educational goals received over \$700,000 in scholarships from funds at ACF.

\$1.7 million in gifts were donated in just over a month by Alaskans and donors from all over the world to support disaster recovery in Western Alaska after Typhoon Merbok.

\$200 million in total grant awards since ACF was founded in 1995.

331 nonprofits, educational organizations, and community groups utilized the BP Energy Center. Donated by BP to ACF in 2020, the facility was reopened to the public in June 2022 after two years of closure due to the pandemic.

11 Affiliates met their fundraising match requirement raising over \$900,000 and receiving an additional \$285,000 in matching funds from ACF and Rasmuson Foundation.

300+ donors, fundholders and partners joined ACF at our first in-person Annual Event since 2019 to celebrate philanthropy in Alaska.

6,000+ donors contributed over \$46 million to funds held at ACF.

18 new funds were opened by donor to support and build philanthropy in Alaska.

34 legacy commitments were made with a current value totaling over \$16 million.




